## TYPES OF MEMBERSHIP

### **Active:**

Shall be any person professionally engaged or interested in the advancement of knowledge relating to the objectives of the Association.

### **Corporate:**

Shall be an organization engaged in the planning, design, construction, operation, conveyance or management of wastewater facilities; a government agency or other corporate body or organization engaged in or interested in at least one of the stated objectives.

### **Professional Wastewater Operators (PWO):**

Must be actively employed by the responsible operating entity on the facility site on a day-to-day basis in the operation and maintenance of wastewater collection facilities or wastewater treatment facilities or wastewater laboratories provided for such treatment facilities.

### **Dual:**

Shall be a person whose residence or place of business is outside of New Jersey and is an active member in good standing of any other member association.

### **Student Member:**

Shall be a regularly enrolled undergraduate or graduate student who spends at least one-half time on academic course work or equivalent.

### **State Association Life Member:**

Shall be a person who has been an active member of the Association for at least 25 years and the attained age of 65 or more and retired from active employment in the field of water pollution control. This person shall be recommended for life membership by the Governing Council and shall be exempt from all dues.

### **Federation Life Member:**

Shall be a person who has been an active member of the Federation for at least 35 years, who shall have been recommended for life membership by the Executive Committee. A life member shall be exempt from all dues.

### **Quarter Century Operators' Club:**

Is an informal group made up of active or corporate members of the Water Environment Federation who have been engaged in wastewater treatment facility operations for at least 25 years.
