- The South Section's 2026 Scholarship application is posted on our website, and March 31, 2026 is the deadline for submission.
- The Section's 2026 Calendar of Events is posted on our website.

- There will be quite a bit of changeover come May 2026 and we are putting together a plan to handle that efficiently as possible – we will set goals and expectations for our new Committee members and have another Orientation Meeting in April 2026
- We are also planning to schedule some training with the State to review how to utilize and post things on our website page

#### **Treasurer's Report: Kathy Collinge**

- The South Sections Association checking account balance as of October 31<sup>st</sup>, 2025 was \$57,497.55.
- The Section's Wells Fargo scholarship portfolio for September 2025 had a closing value of \$26,373.07. This value includes (6) CDs and a Cash Sweep Balance.
  - The breakdown is:
    - \$2000 maturing on March 18, 2026,
    - \$6000 maturing on November 23, 2026,
    - \$2000 maturing on March 18, 2027,
    - \$6000 maturing on May 10, 2027,
    - \$1000 maturing on March 20, 2028,
    - and \$7000 maturing on November 10, 2028.
    - The current market value is \$24,275.12 and the cash and sweep balance is \$2,097.95.
- The most recent reconciliation, current budget vs. actual reports and profit/loss statements were submitted electronically for ratification. The reports are available on request for anyone who would like to look at them. Thank you.

#### **Legislative Report:** Dennis W. Palmer

- Committees are back in the legislature with hearings on Dec 1 and 4 this week and the 8 and 11th next week. It is Lame Duck, so this is a time when legislation can fly through committees.
- Senate Environment Committee;
  - Bill S1042 "Protecting Against Forever Chemicals Act"; establishes requirements, prohibitions, and programs for regulation of perfluoroalkyl and polyfluoroalkyl substances (PFAS).
  - Two bills for nuclear reactors:
  - Bill S4689/A5517 Directs BPU to study feasibility of developing advanced reactors Statewide.
  - Bill S4876 "New Jersey Energy Security and Affordability Act"; establishes advanced nuclear reactor, distributed energy storage, and demand optimization programs in BPU.
- Senate Labor Committee
  - Bill S1518 Establishes procedures and standards regarding public services privatization contracts.  
As amended, this bill prohibits the privatization of public services unless there are cost savings which are not based on increased charges or reduced services to the public, or lowered workforce standards. Each prospective private contractor would be required to demonstrate cost reductions based on improvements such as management efficiencies or technical innovation

- Bill A5991 Requires DEP to establish online flood, rainfall, river level, and sewer capacity dashboard.
