- Today's Safety Topic is particularly important and possibly one of the most violated OSHA Standard in the Wastewater industry. Each year we lose far too many workers to Confined Spaces. Unfortunately, most fatalities are easily preventable, simply by properly following the established regulation and procedure as stated in OSHA 29 CFR 1910.146.
- A good safety measure would include the use of an Entry Permit, a calibrated gas detector, a set up tripod with winch, a full body harness and most important a partner.

- Total income for Vendor's Day 2022 was \$15,830.00, and can be broken down as follows:
  - $\circ$  68 Vendor Tables, including one lunch at \$150.00 each = \$10,200.00
  - $\circ$  57 Extra Vendor Lunches at \$25.00 each = \$1,425.00
  - $\circ$  19 Event Sponsors = \$950.00
  - o 119 Individuals at \$25.00 each = \$2,975.00
  - $\circ$  Profit from sale of 50/50 Tickets = \$280.00
  - Total expenses for 2022 were \$9,114.34, as follows:
  - Rental of Scottish Rite Ballroom & cost of Catering = \$8,687.85

- After coming out of May with much of the focus on the State Budget Hearings, some committees are meeting to review and take action on bills and some new ones have been introduced.
  - o <u>A4183</u>

Concerns local unit filing requirement for certain shared services agreements.

o <u>S2755</u>

Provides public employee salaries at all levels of government cannot exceed salary of Governor.

o A4200 / S790

Requires DEP and owners of certain reservoirs to implement certain flood control measures; authorizes Office of Emergency Management to order lowering of reservoirs levels in response to severe weather events.

o <u>A4066</u>/<u>S2734</u>

Appropriates funds to DEP for environmental infrastructure projects for FY2023.

o <u>A4067</u> / <u>S2735</u>

Authorizes NJ Infrastructure Bank to expend certain sums to make loans for environmental infrastructure projects for FY2023.
