Legislative Report: Dennis W. Palmer, Submitted Report

- The NJ Legislature has had several committee meetings during the beginning of March. On March 16, the Senate Environment Committee held its first meeting of the month.
- Bill S1281 Prohibits sale, manufacture, and distribution of certain apparel containing intentionally added perfluoroalkyl and polyfluoroalkyl substances. This bill would prohibit, beginning two years after the bill's effective date, the sale, manufacture, and distribution of apparel containing intentionally added PFAS within the State. It is a good start to remove PFAS from commerce.
- 3/16/2026 Reported from Senate Committee as a Substitute, 2nd Reading
- This was the only bill in the Senate and Assembly related to our interest. The state budget committees will start meeting on March 18, 24, 25, and 30th, which will result in most other committees not meeting.
 - Other bills of interest are:
 - S3955 -Allows DEP to authorize reformation assessment of certain water and wastewater treatment and conveyance systems.
 - S2706/A4718 Requires public utilities de-privatization study; appropriates \$100,000.
 - S1283/A1067 "Citizen's Fund Act"; establishes trust fund for conveyance of certain public entity assets, as permitted, for interest of public benefit plans.
 - A791— Permits municipalities, counties, school districts, and political subdivisions to withdraw from civil service.
